Cleaning and reconstructing the drainage system running from Mitchell Road by excavating and shaping the ditch, removing obstructions such as sediment, trees and vegetation, and altering damaged and undersized drains in order to restore adequate drainage, and providing access within a new easement for County maintenance.

Located in Columbia Township Original Lot Nos. 79 & 82, Lorain County, Ohio; and commencing in Mitchell Road about 0.3 mile north of Osborne Road; thence running east, then northeast about 0.5 mile to the north line of said Columbia Township Lot No. 79 which is also the south line of Stone Ridge Estates Subdivision as recorded in Volume 90, Page 16 of Lorain County Plat records; as depicted on the attached map.

A list of the names and addresses, where known, of all the owners of the land that the petitioner or the county engineer claims will be benefited or damaged by the construction of the proposed improvement, as determined by the county engineer, is attached.






