WHEREAS, February 19, 2023 Clerk gave notice to the Board that a petition was filed; and

WHEREAS, May 23, 2023 a hearing was held on the Engineer's preliminary report, and testimony for and against the proposed improvement was presented; and

WHEREAS, the Board found that the proposed improvement is necessary, the proposed improvement is conducive to the public welfare, and that it is reasonably certain that the benefits of the proposed improvement will outweigh its costs, and thus the Board has decided to proceed with the project survey and design for the proposed improvement; and

WHEREAS, the route and termini of the proposed improvement will include the alternate route of existing ditch as indicated in the engineer's preliminary report, as well as a reports on a tile and basin; and

WHEREAS, the Board ordered the County Engineer to prepare the reports, plans, and schedules, and said reports, plans, and schedules shall be filed to the Commissioners on September 22, 2023; and

WHEREAS, the Board has decided to proceed with the project survey and design for the proposed improvement known as Roth Main Ditch & Lateral #1.

WHEREAS, September 11, 2023 Engineer requests an extension of time of 90 days to file the plans because the consulting surveyor engaged by the Stormwater District has not yet completed its survey, therefore Engineers Office cannot yet complete their engineering design.

NOW, THEREFORE BE IT RESOLVED, by the Lorain County Board of Commissioners that based upon the request of the Engineers Office we hereby extend the report to be filed on December 19, 2023 and Commissioners will accept such report in January 2024.
